## 1 Promoter's name and address

## 2 How to participate

The competition is open to all non-professional photographers.

All entries must include your name, email address, address (including postcode) and telephone number. You must provide a photograph depicting the theme(s) you have chosen. Caption information supplied must be complete, true and accurate. Entrants should NOT INCLUDE their name in the caption or on the image itself to ensure an anonymous review is undertaken as part of the judging process. Any entry that cannot be authenticated, or is not of acceptable quality is void and will not be entered into the competition.

## 3 Start and closing date

Entries must be received between **1 January 2019 to 31 May 2019.**

## 4 Selection of the winner[s]

All entries will be judged and shortlisted by a panel of judges (including an independent judge). The names of the judges are available on request. Any entries found not to comply with these competition rules may be disqualified. All shortlisted entries will be on display at the Royal Berks Hospital, Reading. The winning entries will be decided and announced by Friday 28 June

2019. That decision shall be final and no further correspondence shall be entered into. You acknowledge that winners may be required to take part in some publicity activity.

## 5 Prize

Prizes will be awarded to the winner and runner up in each category and one for 'Best overall photograph'

There is no alternative prize or cash equivalent. The prize is non-transferable.

## 6 Restrictions and requirements

Employees of the Royal Berks Hospital and their immediate families are eligible to enter this competition.

## 7 Notification of the results and receipt of the prizes

The promoter will notify the winners by email on or before 28 June 2019. The winner will receive their prize on or before 13 July 2018.

## 8 Intellectual Property

8.1 By submitting an entry and in consideration of £5 you grant the promoter an exclusive, non-transferable, world-wide licence to use the Photographic Work in electronic and hard copy format, and in all media. The licence includes the right to store, disclose, print, copy, reproduce, publish, market, distribute, sell, exhibit or otherwise use or exploit the Photographic Work.

8.2 The Photographic Work must be your own original work and not be obscene, defamatory or in breach of any applicable laws. Where third party materials and/or content are used you must provide a copy of such written permissions to the \*RBC.

8.3 If the entrant is not the sole producer and copyright owner of the Photographic Work then written permissions obtained from any co-owner(s) must be provided to the RBC.

8.4 Entry into the competition does not grant you rights in any intellectual property of the RBC. You shall not use any names, logos or associated images of the RBC without our prior written consent.

## **9 Data Protection**

9.1 Entrants must ensure full compliance with all applicable laws, including but not limited to, securing relevant permissions from data subjects identified in the Photographic Work. Evidence of such permission must be made available to the RBC on request.

9.2 When dealing with personal data the RBC shall adhere to the Data Protection Act 1998 and any subsequent legislation to be in force, namely, General Data Protection Regulation/Data protection bill 2018.

## **10 General**

10.1 Insofar as permitted by law the RBC excludes all liability for any loss or damage arising from the competition. Nothing in these terms and conditions will limit the promoter's liability for death or personal injury caused by its negligence or for fraud.

10.2 These terms and conditions shall be governed by and construed in accordance with the laws of England and any disputes shall be subject to the exclusive jurisdiction of the English Courts.
